The ATF has established Committees and Commissions to which the ATF Board of Directors may delegate part of their work. These Committees and Commissions comprise members of the ATF Board of Directors and other suitably qualified individuals.

The duties of each Committee and Commissions are derived from the ATF Constitution and they shall fulfil their duties in a manner that is consistent with the ATF values of good governance, inclusiveness, innovation, ambition, collaboration, integrity, and trust.

### □ Juniors and Coaches Development Committee

The Juniors and Coaches Development Committee is comprised of Chair and Members. The key objectives and areas that lie within the scope of the oversight of the Committee are:

- To organise sustainable and successful Junior Tour and Team Competitions;
- To attract emerging talent into the junior game;
- To retain the best players and deliver them to the professional game;
- To provide opportunities in all member nations for junior players;
- To recommend changes to and to ensure the uniform application of the Rules and Regulations and the Code of Conduct;
- To play decisive role in all matters regarding to tennis coaching and development of coaches in the region;
- Encourage feedback on the activities related to objectives;
- Disseminate information and advantages of the ITF Online academy and active involvement of all nations to take benefit thereof;
- To report to the Board of Directors on all financial matters;
- To submit regular reports to the Board of Directors.

### □ Marketing and Sponsorship Committee

The Marketing and Sponsorship Committee is comprised of Chair and Members.

The key objectives and areas that lie within the scope of the oversight of the Committee are:

- To attract pool of sponsors for the programs of the federation;
- To help prepare packages and proposal for sponsorship of various events and circuits of the federation;
- To help create a healthy financial flow of sponsor grants and contributions for activities of development of the federation;
- To assist in creating a pool of supporting partners from the tennis industry to help ATF disseminate the benefits ahead to the member nations;
- To report to the Board of Directors on all financial matters;
- To submit regular reports to the Board of Directors.

- To oversee the organisation of a sustainable and successful Seniors, Wheelchair and Beach Tennis Tour;
- To maintain and where possible increase the number and spread of nations entries into the Team Competition;
- To increase participation in Seniors, Wheelchair and Beach Tennis in Asia for all ages, genders, playing standards and physical abilities;
- To provide opportunities in all member nations for disabled players;
- To make wheelchair tennis the leading sport for people with a physical impairment.

The duties of the Committee are:

- To manage the Tour, Competitions, Development activities and Classification.
- To recommend changes to and to ensure the uniform application of these Rules and Regulations and Code of Conduct and the ITF & ATF Rules.
- To report to the Board of Directors on all financial matters.
- To submit regular reports to the Board of Directors.

□ Advantage All Committee

The Advantage All Committee is comprised of Chair and Members. The objectives of the Advantage All Committee are to advise and make recommendations to the Board of Directors on the development and implementation of the ITF & ATF Advantage All strategy to promote equal opportunities for girls and women to participate in tennis and the leadership of the sport, in pursuit of the principle of equality of men and women.

The duties of the Committee are as set out, namely:

- The development and implementation of an Advantage All strategy that addresses the ATF's operations as well as the standards, in line with the ITF Strategy that should be set for member national associations;
- The development of ATF position statements on issues related to gender inequality in sport;
- Promotion of the use of sport as a tool for gender equality and empowerment and raising awareness of harassment and abuse in sport;
- Raise awareness of harassment and abuse in sport and input into the ATF's safeguarding policies and practices
- Monitoring, reporting and recognising the progress of ATF member nations and regions in advancing gender equality in participation and leadership; and
- ATF support of initiatives that benefit girls and women, either through participation or leadership.
